This invitation is open to all bidders meeting theminimum eligibility criteria as mentioned in the EoI document.

2. Scope of Work:

Bidders are required to download EOI document from website of the UCMS at www.ucms.ac.in/misc./eoi and go through the EOI document carefully and seek details and clarification from the tenderers in case of any doubt.

The selected bidder shall have to supply turn-key comprehensive and optimum solution i.e. supply, installation, testing, commissioning including civil work and training of all the staff handling the equipment(s) and provide services at its own cost. It shall also include Twenty-Four months of warranty followed by AMC of Thirty-Six months and technical support from the date of installation and commissioning.

The bidder shall be responsible to cover continuing technological development so as to enable video to be accessible more easily, faster, and across multiple platforms and devices.
